**PARENT & STUDENT SPORTS AND EXTRACURRICULAR ACTIVITIES CONSENT (ALL LOCATIONS)
ACADEMIC YEAR 2020-2021**

The Winston Preparatory School (“Winston”) requests permission for your child, a student at Winston (“Student”), and the permission of Student directly, to participate in all Winston sponsored sports and extracurricular activities during the current academic year (“Consent”), and to be transported to and from such activities by public or private transportation, including, without limitation, train, subway, bus, van or automobile, excluding air transportation (together, “Transportation”). This Consent fulfills Winston’s responsibility and obligation to inform you and Student of the inherent risks related to participation in the Transportation and activities, including, without limitation, chess, photography, music, art, theater, newspaper (journalism), running, jumping, climbing, weight lifting, calisthenics, aerobics, basketball, soccer, softball, touch football, floor hockey, wiffle ball, swimming, sailing, rowing (crew), water sports, cross country skiing, and such other activities as Winston offers on its premises, off-site, during or after the school day, and at such other times and locations as Winston may determine (together, the “Activities”).

Although Winston diligently endeavors to follow federal and local health department guidelines and exercises due care at all times to ensure the safety, security and wellbeing of its students, participation in the Activities and associated Transportation may pose serious risks that may not be eliminated or mitigated. These risks include, without limitation, risk of accident, illness, disease, infection, exposure to and contraction of viruses, including the Coronavirus, injury, death, other damages, and the risk that quality emergency or other medical/dental response, care, service and/or treatment may not be accessible, timely, adequate or satisfactory (together, the “Risks”).

Your signature below constitutes the representation, acknowledgement and agreement of each of you as follows:

1. You consent to Student's participation in the Activities and related Transportation.
2. You acknowledge, understand and fully accept and assume the Risks.
3. You authorize Winston, its officers, trustees, employees and agents to obtain emergency and other necessary medical and dental treatment and care for Student, and you accept full financial and other responsibility for such treatment and care, and all costs, fees and expenses, including those incurred to cancel, reschedule and further engage Transportation (including air transportation), as necessary or desirable in Winston’s sole discretion.
4. You represent that Student is in good medical condition, fit to participate in the Activities.
5. You represent that Student has adequate medical and dental insurance coverage for emergency and other treatment, regardless of location, and
6. You release and hold harmless Winston, its trustees, officers, employees and agents from any and all liability, claims, damages, costs and expenses whatsoever, now and in the future, direct and indirect, whether or not the result of Winston's negligence, gross negligence, willful misconduct and/or careless act or omission that may relate to Student’s participation in the Activities and related Transportation, including reasonable attorney fees, costs and expenses.

By signing below, you and Student each acknowledge that you understand and voluntarily agree to the above, effective as of the date below. Exceptions and limitations may be noted in the space provided, and you or Student may modify or withdraw this Consent by delivering a written, signed note to the Head of School.
