Parent and Student Consent and Acknowledgement of Risk  
Outdoor Education and Off-Site Activities (All Locations)  
Academic Year 2020

The Winston Preparatory School (“Winston”) requests permission for your child, a student at Winston (“Student”), and the permission of Student directly, to participate in Winston sponsored outdoor education, adventure and other off-site activities during the current school year (“Consent”), and to be transported to and from such activities by public and private transportation, including, without limitation, train, subway, bus, van and automobile, excluding air transportation (together, “Transportation”). This Consent fulfills Winston’s responsibility and obligation to inform you and Student of the inherent risks related to participation in outdoor and off-site educational trips and activities, including, without limitation, hiking, rock climbing, walking, bowling, skiing, camping, swimming, caving, snorkeling, water sports, boating, sail training and sailing, and excursions outside the school environs (together, the “Activities”). Although Winston diligently endeavors to follow federal and local health department guidelines and exercises due care at all times to ensure the safety, security and wellbeing of its students, participation in the Activities and associated Transportation may pose serious risks that may not be eliminated or mitigated. These risks include, without limitation, risk of accident, illness, disease, infection, exposure to and contraction of viruses, including the Coronavirus, injury, death, other damages, and the risk that quality emergency medical/ dental response, care, service and/or treatment may not be accessible, available, timely, adequate or satisfactory (together, the “Risks”).

Your signatures below constitute the representation, acknowledgement, and agreement of each of you as follows:

1. You consent to Student's participation in all Activities and related Transportation.
2. You acknowledge, understand and fully accept and assume the Risks.
3. You authorize Winston, its officers, trustees, employees and agents to obtain emergency and other necessary medical/dental treatment for Student, and you accept full financial and other responsibility for such care and treatment, and all costs, fees and expenses, including those incurred to cancel, reschedule or further engage Transportation (including air transportation), as necessary or desirable in Winston’s sole discretion.
4. You represent that Student is in good medical condition, fit to participate in all Activities.
5. You represent that Student has adequate insurance coverage for emergency and other medical and dental treatment, regardless of location, and
6. You release and hold harmless Winston, its trustees, officers, employees and agents from any and all liability, claims, damages, costs and expenses whatsoever, now and in the future, direct and indirect, whether or not the result of Winston's negligence, gross negligence, willful misconduct and/or careless act or omission that may relate to Student’s participation in the Activities and related Transportation, including reasonable attorney fees, costs and expenses.

By signing below, you and Student each acknowledge that you understand and voluntarily agree to the above, effective as of the date below. Exceptions and limitations may be noted in the space provided, and you or Student may modify or withdraw this Consent at any time by delivering a written, signed note to the Head of School.
